We, at Mustard Seed Communities, Inc., are committed to respecting the privacy of our donors. We have created this Privacy Policy to inform donors, constituents, and any others who interact with Mustard Seed Communities, Inc. of our online information and data practices. This Privacy Policy applies to all information received by Mustard Seed Communities, Inc., both online and offline, in any format, including electronic, paper, verbal, and through the MSC website.

Acceptance of Terms

By visiting our website, www.mustardseed.com, and/or using our Services, you agree to terms of this Privacy Policy.

Changes to this Privacy Policy

This Privacy Policy is effective as of the date above. Mustard Seed Communities, Inc. reserves the right to revise or update this policy at any time. Changes to this Privacy Policy will be effective immediately upon posting the revised document on our website.

Information Collection and Use

Personal information we collect may include, but is not limited to, your name, postal address, zip code, telephone number, organization name, e-mail address, credit card, bank, or billing information, depending on the type of transaction or correspondence you have with us. Information is collected using a variety of methods. You will be asked to provide personal information when making a donation or requesting information and updates through our website, e-mail, direct mail, or telephone communications. We do not rent, sell, or exchange any personal donor information that is received through our website or stored in our database. We may disclose certain information to select third parties such as total number and value of donations for a set period of time in order to more effectively target our donor communications. This information disclosure is done very carefully to ensure that all personal information and donor-level data is protected.

In addition to the personal information listed above, we receive certain aggregate data from your online activity on our website. This data is collected by us or our technology providers and includes, but is not limited to, your IP addresses, Internet service provider, browser type and language, referring and exit pages and URLs, date and time, amount of time spent on particular pages, number of links you click while on particular pages, search terms, and operating system.

Use of "Cookies"

Our website uses "cookies" in order to enhance your online experience. A "cookie" is a small text file that helps us recognize repeat visitors, facilitate the visitor's ongoing access to and use of the site, track usage behavior, and compile aggregate data that can lead to website improvements. A cookie can be either permanent (i.e., it remains on your computer until you delete it) or temporary (i.e., it lasts only until you close your browser). If you do not want information collected through the use of cookies, you can alter the configuration of most browsers. If you choose to have your browser refuse cookies, it is possible that you will lose some degree of website functionality.

Security

All information provided to MSC is transmitted using SSL (Secure Socket Layer) encryption. SSL is a proven coding system that lets your browser automatically encrypt, or scramble, data before you send it to us. SSL is the industry standard security protocol. We also protect account information by placing it on a secure portion of our database that is only accessible by qualified employees of MSC. Please understand, however, that no data transmission over the Internet is 100% secure. We cannot guarantee the security of our database nor can we guarantee the security of information while it is being transmitted to MSC via either our website or email.
