# Plan Ahead, Care For Loved Ones, Support Mustard Seed

Now is the perfect time to plan for the future — ensuring security for your loved ones and supporting causes close to your heart. By including Mustard Seed Communities in your estate plans, you create a legacy of love and mercy that will last for generations.

## WAYS TO MAKE A LEGACY GIFT:

- Bequest:** Include MSC in your will or trust by designating a specific amount, percentage, or remainder of your estate. This simple, flexible gift can be changed at any time and has no effect on your current finances.
- Beneficiary Designation:** Name MSC as a beneficiary of your bank or brokerage account, retirement plan, or life insurance policy. These gifts are easy to arrange, avoid probate, and may offer tax advantages.
- Retirement Assets:** Designate MSC as a beneficiary of your IRA, 401(k), or other retirement plan. Because these assets can be heavily taxed when left to individuals, they are among the most tax-efficient ways to support charity.
- Donor-Advised Funds (DAFs):** Name MSC as a successor or final beneficiary of your donor-advised fund, ensuring your charitable impact continues well into the future. If no final beneficiary is named, the funds in a DAF become the unrestricted property of the sponsoring organization and are no longer restricted to the donor's wishes.
- Life Insurance:** Name MSC as a beneficiary, or transfer ownership, of a policy you no longer need. It's a meaningful way to make a substantial future gift.
- Gifts That Provide Income:** Establish a Charitable Remainder Trust (CRT) that pays you or another beneficiary income for life or a term of years, with the remaining assets ultimately benefiting MSC.
